# Rationale


The ICT capability overarches Western Australian Curriculum and prepares students to "participate in a knowledge-based economy and to be empowered within a

To achieve our vision the best model of teaching and learning where each student has their own device maximising the opportunity for them to be used. We selected iPad due to a combination of ease of use, familiarity, security, support and range of available software.

In 2020 students in Year 3 - 5 will be required to bring an iPad meeting the specifications outlined below to school. Students in Year 6 will be invited to bring their own device in 2020 and will be required to do so in 2021.



# Hardware

We recommend the iPad 10.2-inch iPad Wi-Fi 128GB (7th Generation).

The 128GB storage capacity is recommended since the required apps and the iPad software take up quite a lot of space leaving limited space for student work. The 32GB model, while acceptable may make it necessary for students to delete media regularly.



### Existing devices

If you already own an iPad you may use that as long as it is able to run the latest version of iOS (iOS 13) and has enough storage to install and use the required apps. Acceptable models are the iPad Air 2 32GB or higher, iPad 9.7-inch 5th or 6th Generation, the iPad mini 3rd Generation 32GB or higher and all models of iPad Pro. If you are unsure please contact the school.

Where a device has a mobile data (cellular) capability this is to be disabled while at school.

### Purchasing

You may choose to purchase from any retailer, however Atwell Primary School has partnered with Winthrop Technology and JB Hifi to offer iPads at a discounted, educational price. Both companies offer extended warranties and insurance and it is recommended that parents consider these when purchasing devices. The price of the 128GB model is \$603 and the 32GB model is \$466.

It is a requirement that parents purchase a suitable protective case for the iPad and provide a pair of sound limited over-ear headphones.

We recommend the purchase of either the Logitech Crayon or Apple Pencil to enable digital inking with the iPad.

# Set Up



Rather than select single use apps we have selected a range of apps that allow students to be creative, develop a broad range of technology skills, work collaboratively and apply critical thinking.

Parents are responsible for installing the required apps on their child's iPad. This may be done by creating an AppleID and visiting the App Store on the device. To create an AppleID visit https://appleid.apple.com/

If you need assistance with this process, please call Apple Support on 1300 760 237 and enter PIN 2961. This is Apple's corporate support and is provide by the Department of Education. It may be accessed 24 hours a day.

The list of required apps will be made available with links on the school's website and is also available in print upon request.

# Care and Consideration

While the iPad remains the property of the student, parents and students must agree to the terms of the acceptable use agreement. The device is not to be used for any activity that is not directly and explicitly endorsed by the school and its staff.

The school and the Department of Education are not responsible for any loss or damage to student owned devices therefore it is important for the device to be insured. When not in use iPads will be secured in locked classrooms.



### Student responsibilities

- As part of the Atwell Primary School 1:1 program students will:
- Ensure their device is brought to school charged each day
- Ensure that their device has sufficient space for school activities
- Use their device in accordance with the school's acceptable usage policy
- · Report any damage to their device
- Ensure that their device is stored securely in a designated area at school when not in use
- Follow all teacher directions concerning their iPad

### Parent/Guardian responsibilities

- Ensure that their child's iPad is in good working order and is free of damage
- Set up an AppleID for their child as per Apple's support document: https://support.apple.com/en-au/HT201084
- Ensure that the iPad has the required apps installed
- Support and reinforce the school's acceptable usage policy
- Access cybersafety resources and take part in the school's cybersafety program
- Keep the iPad operating system and apps up-to-date

### School responsibilities

- Ensure that all staff are trained in using common apps and platforms
- Provide cybersafety resources for parents and students
- Integrate ICT into the curriculum to maximise learning opportunities for students

# Student iPad Agreement

Students must read and sign the One-to-one Student Agreement in the presence of a parent or guardian.
